## Fuel Surcharge Policy

**Action Messenger Service** has implemented a *fuel surcharge* due to the recent astronomical rise in the cost of gasoline. It's important to us that our customers know that we want to provide the best possible service at the lowest possible cost. We're keeping our "base rates" unchanged.

The fuel surcharge will be determined by using the U.S. Government's Department of Energy (DOE) website using the U.S. Retail Gasoline prices by region. The website page is located at:

Gasoline prices for fuel surcharge consideration will be based on the geographic region of the customer's domicile. Example: A customer based in Los Angeles, CA would be subject to the zone described as "California." Las Vegas would be considered "West Coast less California" according to the charts listed on the U.S. Department of Energy's website.

Action Messenger Service will monitor the DOE website every Monday to determine the current rate for the fuel surcharge.

Fuel surcharges will only be applicable to the base rate of any ticketed order.

The purpose is to offset the escalating rise in fuel costs; therefore, the surcharge will not be applicable to extra ticket items such as weight, waiting time or other peripheral charges.
